REPORT FROM ADVISORY COUNCIL CHAIR

It has been another year under the belt for Catholic Charities Legal Network, which has been providing pro bono legal assistance to the poorest of the poor in the Archdiocese of Washington, DC for over 25 years. Our ability to provide this assistance is only possible because of the generosity of our donors, who provide the financial support, and our volunteer attorneys, both those who conduct client intake, as well as those who agree to take on pro bono cases to provide direct legal support.

As a threshold matter, as the new chairman of the Legal Network's Advisory Council, I am grateful for the inspired leadership of my predecessor, David T. Ralston, Jr. I am hopeful that I am adequate to fill his shoes.

I am also gratified that the Legal Network has continued to flourish over this past year. During the past fiscal year, 2016-2017, we provided legal help and referrals to over 3,700 people and delivered approximately \$3,000,000 in legal services for those most in need. For example, the Legal Network was contacted by Ms. M, a colon cancer victim, who took medical leave to have her cancer treated. Upon her return, her employer gave her the Hobson's choice of resigning or being terminated. The Legal Network referred the case to a volunteer attorney, Robert B. Fitzpatrick, who was successful in securing a complete reinstatement for Ms. M - just one example of the many lives the Legal Network touched.

In addition to the Advisory Council, we have also recently established a Young Lawyer's Committee -- a group of young attorneys who are dedicated to supporting the Legal Network both financially, through fundraising, and substantively by assisting with novel ideas on better ways to assist our clientele. It is inspiring to see these young lawyers work; they will ensure the continued success of the Legal Network.

The future of the Legal Network is very bright. In the fall of 2017, the Susan Denison Mona Center, a new Catholic Charities facility in Temple Hills, MD, opened. The Mona Center houses, among other service providers, a new Legal Network office, which will better allow us to serve low income clients in Prince George's County. Many thanks are due to the benevolent generosity of Vincent "Cap" Mona, who donated the building that will become the Mona Center.

A special recognition is due to our fearless leader, Jim Bishop, the Director of the Legal Network. Without his tireless and selfless efforts, none of this is possible. Jim not only keeps the trains running on time, but he has a care and empathy for our clientele that is palpable. Finally, we are especially grateful for the support of Catholic Charities and its President, Rev. Monsignor John J. Enzler. With Father John it is not let me see what I can do - it is what do you need and let's make it happen. However, at the end of the day, it is all of you that make this Legal Network possible. And with your continued, and greatly appreciated, assistance, the Legal Network can continue its vital mission of providing pro bono legal help to those who are most vulnerable in our community.

Dear Friends,

Catholic Charities Legal Network completed an exciting and successful fiscal year. Our many accomplishments include:

- Providing pro bono legal services to 3,707 low-income metropolitan Washington residents.
- Conducting 5 civil law seminars in the District of Columbia to 110 low-income residents.
- An Advisory Council member providing information on our services to local residents at an information fair in Ward 8.
- Presenting 7 legal trainings and information sessions to 155 attorneys from area law firms and law schools. We recruited attorneys at these trainings, helping the Legal Network maintain an attorney volunteer pool of approximately 700 lawyers.
- Strengthening alliances with law schools, including American University Washington College of Law, Catholic University's Columbus School of Law, George Washington University Law School, Georgetown University Law Center, Howard University School of Law, Notre Dame Law School, and the University of the District of Columbia's David A. Clarke School of Law.
- Maintaining partnerships with the Pro Bono Coordinating Council in Maryland and the DC Consortium of Legal Services Providers.

These achievements are made possible because of the enduring support of this program's friends and financial supporters. The Legal Network is fortunate to benefit from the financial and in-kind support of people like you, as well as charitable foundations and law firms large and small. Of particular importance is the long-standing relationship the Legal Network enjoys with the District of Columbia Bar Foundation, which funds our bilingual paralegal position. For nearly 28 years, the Legal Network has been at the forefront of empowering the uneducated, the undereducated, the disabled, and the poor to defend their legal rights. I would like to thank John E. McCarthy, Jr., the chairperson of Catholic Charities Legal Network's Advisory Council; the wonderful 24 members of the Council; Monsignor John J. Enzler, President of Catholic Charities of the Archdiocese of Washington; and Denise A. Capaci, LICSW, Executive Director of Adult & Children's Services of Catholic Charities.

How We Help

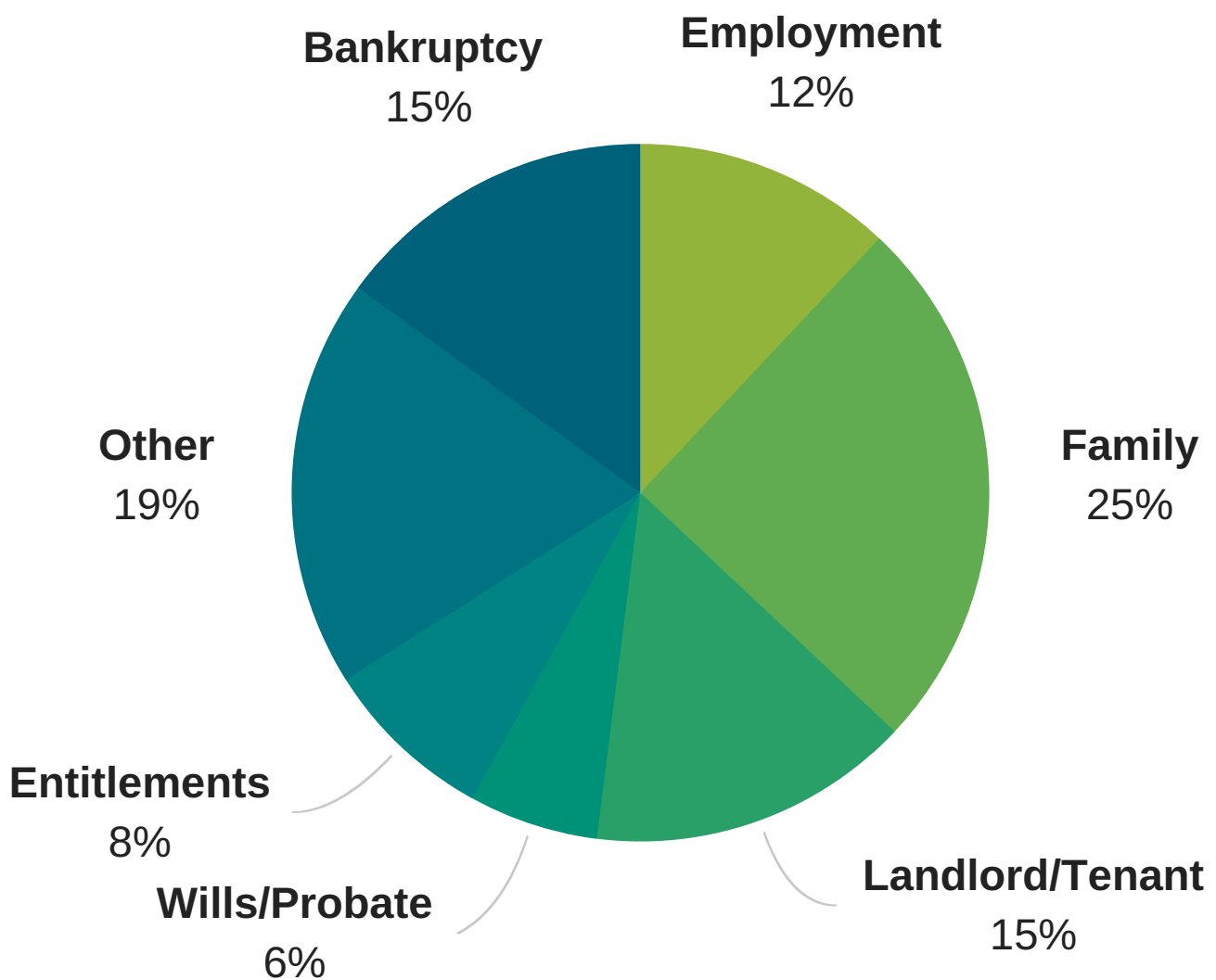
