## 2019 | 2020 Chairperson's Letter



Dear Friends,

The Catholic Charities Legal Network had another very productive year in meeting our mission to provide pro bono legal services to indigent and poor residents in the Archdiocese of Washington. Our success came through a combination of new initiatives, with new volunteers and Legal Network staff, as well as a continuation of our historical core work of case screening and placement.

One of the exciting developments over this past fiscal year has been the growth of our presence in the Prince George's County legal community. With our base at the Catholic Charities Susan Denison Mona Center in Temple Hills, Maryland, the Honorable Leo E. Green, Jr., Retired Associate Judge for the Circuit Court for Prince George's County, Maryland, is making a great difference for low-income individuals and families in Prince George's County, Leo, working closely with our stalwart staff attorney Dan Collopy, led our efforts to generate 244 docketed cases and recruit 125 attorney volunteers. A grateful shout out to Advisory Council member Tim Maloney and his firm,

Joseph Greenwald & Laake, PA, for hosting a reception in November 2019 to welcome Judge Green and challenge attorneys to volunteer their time to work on a pro bono case through the Legal Network.

Another initiative implemented by Legal Network volunteers in this fiscal year has been to assist veterans by becoming the Washington, DC, coordination center for VetLex. VetLex is a nationwide program connecting veterans with pro bono representation for matters such as Veterans Benefits Administration appeals and upgrades to the status of discharges from service, in addition to other non-veteranrelated legal matters. A special thanks to Advisory Council member Miguel Eaton and his colleagues at Jones Day who have spearheaded this VetLex initiative.

This expansion of activities has not diminished the Legal Network's traditional focus of meeting the legal services needs of our community in matters involving bankruptcy and consumer debt, employment law, family law, landlord-tenant issues, government entitlements, and will drafting/ estate matters. All told, our volunteers enabled the Legal Network to provide assistance to nearly 3,300 individuals this past year.

Leading all of the Legal Network's efforts with organizational skill and manifest empathy for our clients is Jim Bishop, Director of the Legal Network soon entering his 27th year serving the constituencies of the program. Jim is supported by the hardworking and effective Legal Network staff, which performs so well on many fronts. From facilitating the intake of potential clients to organizing our fundraising efforts, coordinating volunteer attorney recruitment and training to organizing receptions, the Legal Network staff juggles many responsibilities without dropping a ball. And backstopping all Legal Network activities is Catholic Charities of the Archdiocese of Washington and its President, Msgr. John J. Enzler, who is ever a font of ideas and resources.

volunteer attorneys has been all-the-more impressive in meeting the community's legal needs as the COVID-19 pandemic descended on us. Staff and volunteers stepped up telephonic intake when in-person client visits were no longer possible. Working from home offices to make sure clients were not forgotten and court deadlines continued to be met, notwithstanding competing demands of family and personal lives, was remarkable.

Lastly, and most importantly, I would like to thank all our volunteers and benefactors – the lifeblood of the Legal Network. Without your time, talents, and treasure, the Legal Network simply would not function. We sincerely appreciate your vital support of the Legal Network's mission to serve the legal needs of our community's disadvantaged individuals and families.

Dear Friends,

I completed my twenty-sixth year as Director of Catholic Charities Legal Network, as our program completed over thirty years of service to the public. I am pleased to report that in Fiscal Year 2020, the Legal Network assisted 3,278 individuals by providing direct legal representation and presenting legal education seminars in the District of Columbia and Maryland.

This year was not without challenges. Since March 16, 2020, Catholic Charities Legal Network has been conducting all its client services on a remote basis due to the COVID-19 pandemic and work from home mandates in the Washington Metropolitan Area. The Legal Network's services are still verv much in demand, since many of our clients have experienced problems with their jobs, child custody and other family disputes, landlord-tenant concerns, and growing consumer debt issues. There is a silver lining in this cloud, however, since many of our clients are still able to communicate with our staff by telephone and email. The remote telephone service has also been helpful to several of our clients who still need legal help while either they or immediate family

members are recovering from COVID-19. The Legal Network's staff has conducted virtual presentations on wills and advanced medical directives to both Catholic Charities staff as well as to patients, clients, and consumers throughout the agency. In fact, six such presentations were conducted by the staff during May and June 2020. After the presentations, some requested wills and related legal documents, which the Legal Network's staff have helped them obtain in an expeditious fashion. Many thanks to Esther D. Coleman, staff attorney, who has led the charge in assisting our clients with wills and advanced directive documents since the guarantine began.

With all the challenges of late, the Legal Network still has many causes for celebration. First, we continue to be grateful for our selfless volunteers who give so freely of their time and use their legal skills to assist their neighbors in need. Thank you to those volunteers for conducting telephone and in-person intake weekly and monthly. Special thanks also to our government, solo, mid-size, and large law firm attorneys who accepted pro bono cases from the Legal Network, directly impacting lives for the better. This past year, the Legal Network was blessed to have an attorney devote an extraordinary amount of time to the program and its clients. Deacon Darryl A. Kelley is a deacon at St. Philip the Apostle Church in Camp Springs, Maryland, and he was assigned, through the deaconate program, to the Legal Network by the Archdiocese of Washington. He assists at the Susan Denison Mona Center in Prince George's County while managing a general law practice in Camp Springs. Deacon Kelley has accepted many pro bono cases from the Legal Network.

I am especially appreciative of the Legal Network's staff for their commitment to serving the poor and underserved in our community. Thank you to staff attorneys Esther D. Coleman, Daniel F. Collopy, Hon. Leo E. Green, Jr., and supervising attorney, Kelly E. Thompson. I also want to thank the Legal Network's bilingual paralegal, Blanca Lopez.

Of particular importance to this program is the Legal Network Advisory Council.

I am particularly grateful to all Council members and the Advisory Chairman, James P. Gillespie, for their support and encouragement.

Lastly, I am thankful for the financial support the Legal Network has received from its many donors and partners.

Though we have more work to do, I am proud of what we have been able to accomplish over the last year, and I invite you to peruse this report to learn more about our successes.

## 2019 | 2020 Catholic Charities Legal Network's Impact

The support of volunteer attorneys from law firms, the government, and solo practices allows the Legal Network to fulfill its mission of offering free legal assistance to the poor. These volunteers provide pro bono legal representation and conduct inperson intake with clients. Volunteer attorneys also monitor the Legal Network's telephone intake line and schedule clients for in-person intake, providing referrals when appropriate. Additionally, they present civil law seminars for low-income groups, and they mentor attorneys who handle pro bono cases.

The Legal Network assists families and individuals who earn at or below 250% of the Federal Poverty Guidelines. For an individual seeking the Legal Network's services in 2020, the income limit is \$31,900, and for a family of four, the limit is \$65,500. 3,278 low-income individuals were served in Maryland and Washington, DC during the fiscal year.



### 2019 | 2020 Volunteer Spotlight



When someone calls the Catholic Charities Legal Network intake line, they are screened for case type, case jurisdiction, and income. If someone seems to qualify, they are then scheduled for a second-stage intake appointment with a staff or volunteer attorney for a more thorough analysis of their legal matter. Traditionally, these second-stage intake appointments occurred in person at one of the Legal Network's offices. However, once stay at home orders were put into place because of the current COVID-19 pandemic, volunteer attorneys like Theresa Hyatte stepped up to conduct these intakes remotely.

Theresa sees intake as encompassing two main goals: 1) to learn about the client's situation so the Legal Network can find the right attorney volunteer to help them; and 2) to just listen. "When people call for help, they are often facing a crisis, and they are feeling vulnerable and overwhelmed," Theresa said. "An important part of my work in intake is to make the client feel like they are being heard and that what is happening in their life is important and matters to us."

Theresa has not been conducting these remote appointments alone. This summer, she has been assisted by her son, Hank. Hank has been helping his mother by taking notes during the calls, navigating technological challenges, and entering clients' information into the case management system. By having her son assist with these remote intakes, Theresa says that she is better able to focus on being present to the clients and just listening to them, without being preoccupied with the challenges that go along with working remotely.

Working together has also given the two a chance to see a different side of each other. "It has given me a chance to see my son as an equal and to see him in a different role," Theresa said. "I've enjoyed working with him because we are serving our community in a way that is allowing us to live out our Catholic values together."

This experience has allowed Hank, who enjoys service and helping people in need, to explore his interests in law more fully. "I'm getting to see how things work, the situations involved, and the processes you go through in helping people in need," Hank said. His work with his mother on intake for Catholic Charities Legal Network has given Hank the opportunity to tie in his Catholic faith with his interest in law.

As mother and son, Theresa and Hank have been helping people navigate the legal landscape amidst worries and concerns about COVID-19. From custody disputes involving parents concerned about the virus being transmitted from one home to the other, to people who have been directly impacted by COVID-19 through the loss of jobs, health, and even their homes, every client they have encountered together has faced their own unique challenges regarding the pandemic.

"Normally what people do in life is walk on a tightrope," Theresa said. "COVID took that tight rope, which might have been five feet off the ground, and raised it up to about thirty feet. It is important that we as Catholics help secure the social safety net for people walking that tightrope. Every person counts."

The Catholic Charities Legal Network FY 2019-2020 Annual Report is dedicated to the Honorable Arthur L. Burnett, Sr.

At age 34 in the year 1969, Judge Burnett was appointed the first African American United States Magistrate Judge in the United States District Court for the District of Columbia. He served six years of an eight year term before being persuaded to become the Assistant General Counsel of the former United States Civil Service system,

where he became the principal author of the Civil Service Act of 1978 and advisor to the President of the United States. Judge Burnett returned to the United States District Court in 1980, where he served until appointed to the Superior Court of the District of Columbia in 1987. While on the bench in the Superior Court, he served as Judge and Senior Judge until 2004.

After retirement, Judge Burnett continues to be involved in several local and national organizations. On August 13, 2020, he shared an oral history of his amazing life experiences from childhood in Virginia, to practicing lawyer, to a respected judge of many years. Thanks to the Archdiocese of Washington, in conjunction with Catholic Charities of the Archdiocese of Washington, a documentary film of his life experiences was made in order to be shared with students, aspiring lawyers, parishioners and others through both of our organizations. 
