In fact, that commitment to "selfless service" marked Robert's three-month fellowship this fall with the Legal Network as it did his time as an undergrad at Dartmouth, where he served as Grand Knight of the local Knights of Columbus council and president of Vita Clamantis, the school's pro-life group. "In a short period of time, we've come to rely on Robert's remarkable judgment in coordinating our substantial case intake and referral program," said Legal Network Director James Bishop. "Only a very talented person could have picked up the subtle yet complicated, practical as well as legal, nuances of the job," he added. And yet, Robert says it was a genuine pleasure: "I've enjoyed this rare opportunity to interact with people who need help and to translate their needs into a legal narrative for other volunteer attorneys. It's my Catholic faith that motivates me to fulfill the Legal Network's mission."

Recently, Fern completed his term as a member of the Legal Network's Advisory Council. Since 2013, he cites his biggest achievements on the council as including participation in last year's launch of the Susan D. Mona Center in Prince George's County where the satellite office is already recording significant impact on the surrounding community's most needful. "We planned long and hard to project our services into that community within the Archdiocese," Fern noted. He says he's also excited about the establishment of the Legal Network's ID Card Project, which is designed to help the homeless pull together those documents typically needed to obtain gainful employment. "It offers ways for attorneys to do a lot of good for those in need without always making a significant time commitment to any one case." Yet, in a larger sense, Fern says he is most grateful about the ongoing vitality of the Legal Network's various efforts under his watch to bring legal representation "to the underserved in our community."

There's yet another hat to consider. That is, like many Jones Day partners, Fern "takes very seriously" mentoring his junior colleagues, including showing them how pro bono work helps them grow as lawyers as well as persons. The potential harvest is plentiful, he suggests. For example, Fern credits Jones Day Associate Robin Overby as being a major contributor to Legal Network's ID Card Project and praises her for subsequent commitment to his firm's flag ship "Loredo Project," which provides nation-wide legal representation to unaccompanied minors of foreign or undocumented individuals. After all, he concluded, making a "real difference" through pro bono representations is "part of any attorney's professional obligation. It's fundamental to the Rule of Law and a bed rock of our pluralistic society."



66th Annual Red Mass

As is the John Carroll Society's ("JCS") tradition, the 66th Annual Red Mass celebrating members of the legal profession's good works was well attended by members of the Catholic Charities Legal Network, as well as prominent members of the DC legal community. In attendance at the Cathedral of St. Matthew the Apostle were 3 members of the Supreme Court: Chief Justice John Roberts, Justice Clarence Thomas, and Justice Stephen Breyer. Also present were U.S. Attorney General Jeff Sessions and Solicitor General Noel Francisco. "I think the Holy Spirit was in the church," Msgr. Peter J. Vaghi, told Catholic News Service following the Mass. In alluding to today's most troubling legal as well as ethical controversies, the chaplain of the JCS added there "could not be a better time, both in our church and nation, to benefit from the healing power the Holy Spirit."

John Carroll Society Awards

The JCS's Annual Red Mass Brunch immediately following the services featured the recognition of two local attorneys and two law firms for their exceptional representation of the poor. This year's *Pro Bono* Legal Service Awards for outstanding volunteer service to low-income individuals in the Washington region were: Ari Q. Fitzgerald; Gerard E. Mitchell; the firm of Drinker Biddle & Reath LLP; and Jones Day. Those individuals and firms honored at the Mayflower Hotel gala on Sunday, September 30 are volunteers with the Catholic Charities Legal Network.



Mr. Fitzgerald is a partner with Hogan Lovells US LLP who served as a member of CCLN's Advisory Council from 2011 to 2017. Among other things, he helped Catholic Charities expand its services in to Prince George's County at the new and already busy Susan D. Mona Center.

Mr. Mitchell is a partner at Stein Mitchell Cipollone Beato & Missner LLP who volunteered to handle a daunting case referred to him by the Legal Network, resulting in the successful defense of a complex personal injury case.

Drinker Biddle & Reath LLP was recognized for its attorneys' unstinting in-person intake for the Legal Network for the past five years. Particularly noted was the firm's DC partner in charge, Maureen Donahue Hardwick, who has vigorously promoted *pro bono* work among the firm's DC attorneys, and Thomas J. Kelly, a firm partner and Legal Network Advisory Council member who devoted many hours of time this year successfully representing a *pro bono* client in DC's Superior Court.

Jones Day attorneys have likewise been active contributors to the Legal Network. Partner, Fernand A. CCLN Annual Report preview

The Catholic Charities Legal Network's soon to be released Annual Report for the 2017-2018 fiscal year will include some revealing statistics about the breadth and depth of its services to the underrepresented and poor. For instance, the Legal Network's 700 individual attorneys and their more than 45 law firms assisted over 3,707 clients in Washington, D.C. and its surrounding Maryland counties. Moreover, the CCLN's Docket System recorded 558 cases that were opened during the last 12 months in many practice areas.
