### **CCLN Client Success Story**

During the past year, the Catholic Charities Legal Network was able to support and assist a young immigrant who was caught in a destructive

marriage with a verbally abusive husband, who also immigrated to the United States. Both had been in this country for many years. While her husband was able to purchase a home within the last few years, his drug/alcohol abuse and infidelity drove a huge wedge between the two. They also lived together in the home with his younger sister who our client cared for and supported. She was like a mother to the child.

Finally, the husband moved out of the home and threats were made by him and his father to sell the home and leave our client out in the street with nothing. The home was only titled in the husband's name and he worked for his father. Our client earns very little but she is a huge asset in assisting the local religious sisters in the area. CCLN attorneys worked diligently to secure the rights and financial support for our young client and we were successful in bringing the father and son to the table to do the right thing and support our client for years to come.
