The Catholic Charities Legal Network, under the leadership of Director Jim Bishop, continues to provide exemplary free legal services to those in need in our community. The Legal Network assists in many areas of law including Bankruptcy, Consumer Law, Employment Law, Family Law, Government Entitlements, Landlord and Tenant Law, and Wills and Advanced Medical Directives. The Advisory Council to the Legal Network has benefited immensely over the years from the dedicated service of John E. McCarthy, Jr., Senior Counsel at Crowell & Moring, LLP, who anticipates retiring from the full-time practice of law next year. John earned the title of Chairperson Emeritus of the Legal Network some time ago and I hope he continues to support the Legal Network in that role in the future. His assistance and dedication to the Legal Network, and other causes, have been invaluable.

I would also like to acknowledge Howard "Hank" Hyatte who has been an intern with the Legal Network every summer since 2022. He has been essential for projects like the Legal Network's annual reports and has provided valuable support to intake and other daily needs in the office. Joyce Chung, who volunteered with us this year and last, should also be acknowledged for her work including organizing Know-Your-Rights seminars, facilitating pro bono placements, and compiling statistical reports on the Legal Network's activities.

McCarthy, Jr. The funds raised at the event support the cost of an additional attorney in the office to support those in need.

Additionally, it is appropriate to thank Emma Johnston for her tireless work with the Legal Network's client processes as well as establishing law-related seminars, both in English and Spanish, for individuals living in the District of Columbia. And Deacon Darryl A. Kelley, a great friend and tireless worker, continues to help those that could not afford legal assistance in a variety of civil law cases. His work in the Church and his charitable work for the Legal Network is an inspiration to us all.

Let me relay one short story before I close, as this story is emblematic of the support that is being provided to our community every day and for which we should all be proud. One morning last year, Jim Bishop was making his way to work at Catholic Charities in downtown Washington, DC. As he neared the door to the building, he was stopped by a man who was seeking assistance. It turns out the man, his wife, and their two children were homeless and had only the clothes on their backs. Through Jim's efforts, with the support of Catholic Charities, the family obtained housing, food, job placement guidance, and assistance in getting the children into school. Without Jim's intervention and guidance, the family would have been left in their destitute state. Thank you, Jim, for doing caring work, not only in running the Legal Network, but also in assisting those in need of more basic support. I am honored to be associated with you and the work you do. Thank you for making 2025 another remarkably successful year for the Legal Network.

Dear Friends,

I completed my 31st year as Director of Catholic Charities Legal Network, as our program completed over 35 years of service to the public. I am pleased to report that in Fiscal Year 2025, the Legal Network assisted 1,525 individuals by providing direct legal representation and presenting legal education seminars in the District of Columbia and Maryland. I am also proud to report that our volunteers self-reported 3386.29 pro bono hours valued at \$2,387,720.50.

Each year, the needs and number of our clients in the D.C. area seem to grow ever-larger, especially with issues of employment, domestic and custody disputes, landlord-tenant concerns, and looming consumer debt. Instead of despairing, we should see this as an opportunity to do more great work for these underserved groups. But our capacity to meet these needs is inhibited by the reduced size of our program's staff. Increased revenue is needed to hire additional staff attorneys, administrative assistants, and law student interns. I would like to thank the District of Columbia Bar Foundation for awarding us a grant to fund the bilingual paralegal position held by Emma Johnston on a full-time basis. Still, there is much work to be done.

Nevertheless, we have managed to serve a greater number of individuals this year than the last due to the hard work of our small team and our volunteers. When an expanded staff becomes available to us, it will combine with that spirit of diligence and service to the benefit of all those in need of legal aid.

In the face of all these challenges, the Legal Network still has many causes for celebration. First, we continue to be grateful for our selfless volunteers who give so freely of their time and use their legal skills to assist their neighbors in need. Thank you to those volunteers for conducting telephone and in-person intake weekly and monthly. Special thanks also to our

government, solo, mid-size, and large law firm attorneys who accepted pro bono cases from the Legal Network, directly impacting lives for the better. We also thank the Catholic Charities Grants Department for helping us by writing major grants for the program, and the Development Office for helping us raise funds through contributions. Your help has been and will continue to be essential to the operations of the Legal Network. This past year, the Legal Network was blessed to have attorneys devote extraordinary amounts of time to the program and its clients. This includes Deacon Darryl A. Kelley, deacon at St. John the Evangelist Church in Clinton, Maryland, and his zealous representation of clients on a pro bono basis in the Prince George's County court system, and Patrick J. Kennedy, a retired federal government attorney who assists the Legal Network staff on a weekly basis at our Hickey Center office in assessing each client's case.

I am especially appreciative of the Legal Network's staff for their commitment to serving the poor and underserved in our community.

Of particular importance to this program is the Legal Network Advisory Council.

I am grateful to all Council members and the Advisory Chairman, Andrew N. Cook, Esq., for their support and encouragement.

I am also thankful for the continued support of the president and CEO of Catholic Charities of the Archdiocese of Washington, Jim Malloy.

Lastly, I am thankful for the financial support the Legal Network has received from its many donors and partners.

Though we have more work to do, I am proud of what we have been able to accomplish over the last year, and I invite you to peruse this report to learn more about our successes.

Catholic Charities Legal Network’s (CCLN) Impact

The support of volunteer attorneys from law firms, the government, and solo practices allows the Legal Network to fulfill its mission of offering free legal assistance to the poor. These volunteers provide pro bono legal representation and conduct intake with clients. Volunteer attorneys also monitor the Legal Network’s telephone intake line and schedule clients for in-person intake, providing referrals when appropriate. Additionally, they present civil law seminars for low-income groups, and they mentor attorneys who handle pro bono cases.

The Legal Network assists families and individuals who earn at or below 250% of the Federal Poverty Guidelines. For an individual seeking the Legal Network’s services in 2025, the income limit is \$39,125, and for a family of four, the limit is \$80,375. A total of 1,525 low-income individuals were served in Maryland and Washington, DC during the fiscal year.

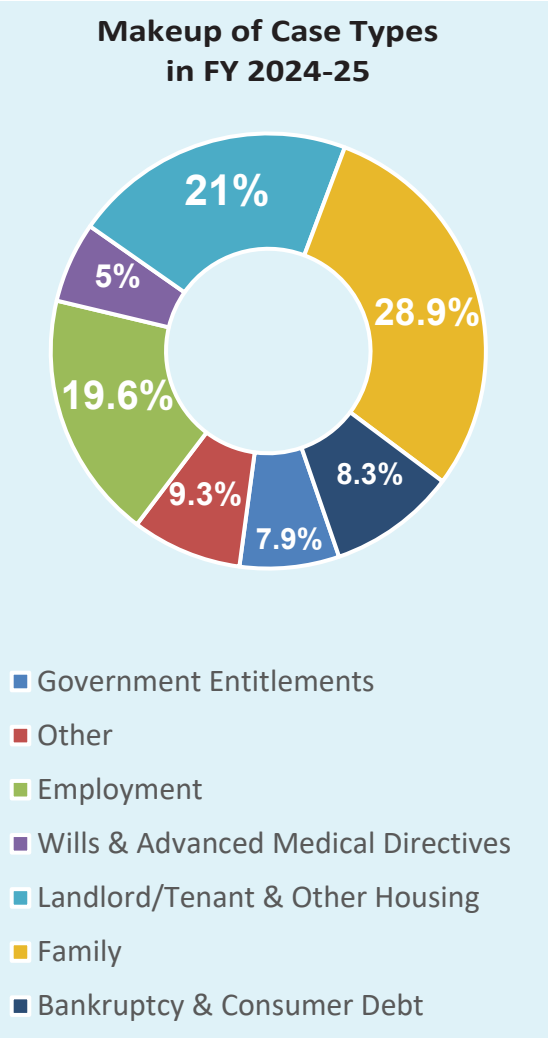

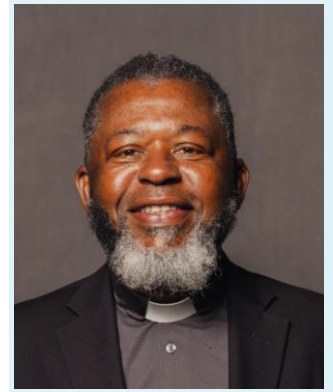
James D. Bishop, Esq.
Director, Catholic Charities Legal Network

Jim's entire professional career has been serving low-income and people experiencing homelessness for close to 40 years, 31 of those directing CCLN. Prior to accepting the position as Director of CCLN of DC in December 1993, he was employed for eight years at the mandatory District of Columbia Bar in several public interest positions. He is a parishioner of Saint Patrick's Catholic Church in downtown DC and a third generation native Washingtonian. Jim was a family mediator in the Superior Court of the District of Columbia's Multi-Door Dispute Resolution Division for over 30 years. He has served on the Board of Governors of the John Carroll Society, the Civic Board of Directors of the Council for Court Excellence, and the District of Columbia Bar Foundation's Scoutt Prize Committee. His honors include the Equal Justice Award from the University of the District of Columbia's David A. Clarke School of Law, the Bar Association of the District of Columbia's Suzanne V. Richards Award, the Jerrold Scoutt Prize from the DC Bar Foundation, the John Carroll Society Medal, the Archdiocese of Washington's 75th Anniversary Cardinal's Award, and Catholic Charities' Griffin Award. While Jim has been at the helm of CCLN, the program has assisted approximately 85,000 low-income and homeless D.C. and Maryland residents with a variety of civil law cases such as child custody, social security, and bankruptcy matters. He has made sure that residents are educated about their legal rights in such areas as consumer/fraud, child custody, and wills and advanced medical directives by conducting seminars at local churches, senior citizen organizations, transitional and low-barrier shelters. Jim is a magna cum laude graduate of Lincoln University in Pennsylvania. He was President of Lincoln's Alpha Chi Honor Society, and a graduate of Howard University School of Law. Jim holds a certificate from the University of Notre Dame Mendoza College of Business for completing the Nonprofit Business Excellence Program for Catholic Leaders. Jim is a member of the Knights of Columbus, Council 224 and of the United States Supreme Court, District of Columbia, and Pennsylvania Bars.



Deacon Darryl A. Kelley, Esq.
Staff Attorney, Catholic Charities Legal Network

Deacon Kelley is a resident of Prince George's County and has a law practice in Camp Springs, Maryland. Deacon Kelley began accepting pro bono matters from CCLN in 2018. His cases for CCLN involve family, estate, landlord/tenant, and bankruptcy matters. He currently serves as deacon at St. John the Evangelist Catholic Church and serves as a Public Policy Advisor for the Archdiocese of Washington's Public Policy Team. He is a former Maryland State Delegate for the 26th Legislative District and previously served as Legislative Assistant for Education and Labor to former United States Senator Paul S. Sarbanes. Deacon Kelley continues to serve on local committees in the county, supports global peace initiatives, and serves on the Board of Directors for the Forestville Pregnancy Center in Marlow Heights, Maryland. He is now the chairman of the Juvenile Services Education Program Board and the second vice president of the John Carroll Society. Deacon Kelley also served as an Inspector/Deputy United States Marshal for many years in federal law enforcement. He completed the Capitol Hill Fellowship Program, Government Affairs Institute at Georgetown University, and graduated from the University of Maryland School of Law and the University of Virginia with a Bachelor of Arts in History. Deacon Kelley is licensed to practice law in both Maryland and the District of Columbia. In 2024, he became the first deacon and layman to give the homily at the Red Mass.

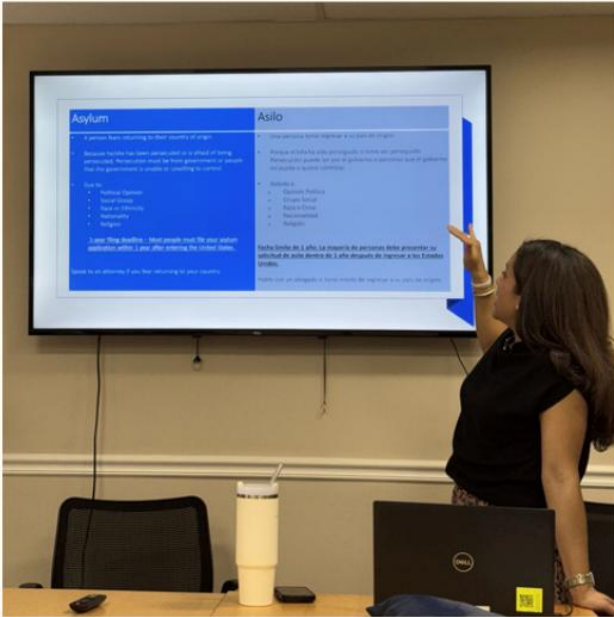
